Event Recap BDA Seminar on Fixed Income Regulation *Featuring Nixon Peabody*

On December 4th, BDA hosted a seminar on fixed income regulation in Minneapolis which featured BDA retained counsel Nixon Peabody. The seminar was the first in a series of regulatory-focused events entitled, "The Brave New World of Fixed Income Regulation."

 - Discussion of different approaches to complying with time of trade disclosures
 - Review of recent member exam experiences and how FINRA is currently approaching time of trade disclosures
